Notice is hereby given of a meeting of the City Council of the City of Anson to be held on Monday, March 23, 2020, 6:00 p.m. at the Anson City Hall 1301 Commercial Ave, Anson, TX 79501 for the purpose of considering the following agenda items.

Call meeting to order and opening prayer

- A. Discuss and take action on the February 24, 2020 City Council meeting minutes.**
- B. Discuss and take action on the March 16, 2020 Special Call City Council minutes.**
- C. Presentation from Citizens. No formal action may be taken. (Limit 5 minutes per spokesperson).**
- D. Discuss and take action on the proposed City of Anson 2020-2021 Budget.**
- E. Discuss and take action on passing an Order continuing a Declaration of Local State of Disaster for the City of Anson. The Council may adjourn into executive session as allowed in Texas Gov't Code § 551.071 (Consultation with Attorney).**
- F. Discuss and take action on re-appointing Rowland Foster to the West Central Texas Municipal Water Development District Board.**
- G. Discuss and take action on Ordering the May 2, 2020 General & Special Election to be postponed to the November 3, 2020 uniform election date pursuant to the Proclamation issued March 18, 2020 by Governor Greg Abbott that authorizes this entity to exercise that authority. Candidate filings for the election will remain valid for the November 3rd election date as the postponement does not reopen candidate filings. All Applications for Ballot by Mail voters due to being over the age of 65 or due to disability received for the May election will still be valid for the postponed election in November. The updated voter registration deadline shall be October 5, 2020, the updated deadline to submit an Application for Ballot by Mail shall be October 23rd, 2020, and the updated dates for early voting shall be October 19, 2020 – October 30, 2020.**
- H. Discuss and take action on the Industrial Development Corporation's grant to the Anson Golf Course Association for the amount of up to \$30,000.00 for improvements to the Anson Golf Course Club House.**
- I. Discuss and take action on entering into a contract for EMS services. (The Council may adjourn into executive session as set forth in Texas Gov't Code 551.071 Consultation with attorney.)**


