In accordance with order of the Office of the Governor issued March 16, 2020, the City Council of the City of Anson will conduct this Special Called Meeting in the City Council Chambers, located at 1301 Commercial Avenue, Anson, Texas by video/telephone conference in order to advance the public health goal of limiting face-to-face meetings (also called "social distancing") to slow the spread of the Coronavirus (COVID-19). The members of the City Council will participate in this meeting either in person or remotely through video conference providing for two-way video and audio communication for each member of the City Council.


